### 2. Eligibility

- Minimum of 1-year experience in the Hospitality or Tourism industry, including probation, of continuous and satisfactory service with the nominating agency at the time of submitting application.
- Should have completed at least class XII or equivalent.

  - a) Why are you applying for this course and what are your expectations?
  - b) Why have you chosen Tourism or Hospital Management and Teacher Training or Entrepreneurship?
  - c) What are your professional plans after your return and how are you going to use the knowledge gained at ITH?
- j. Video selfie (refer to the separate information sheet for detailed instructions)
- ii.) Duly filled in-service HRD form (<u>Download</u>) along with following documents (separate from the application form);
  - a. Citizenship ID copy
  - b. Valid security clearance
  - c. Appointment letter
