#### Foreword

With the blessing and, continuous support and guidance from our successive Monarchs and governments, Education has been accorded the highest priority since the beginning of planned socio-economic development in the 1960s. Under their benevolent leadership, Bhutan has made commendable progress in terms of expanding access to education at all levels over the past six decades. Particularly, access to ECCD has improved with Gross Enrollment Ratio of 25.3% in 2019 within a short period. And, almost all school-going aged children are now enrolled in school with the Adjusted Net Enrolment Rate (ANER) at 96.5% as of 2019, close to achieving universal primary education. Similarly, enrolment in tertiary education has improved with the Gross Enrolment Ratio (GER) within and outside Bhutan (19-23 years old) of 24.9% in 2019.

Taking forward from numerous achievements, the Ministry continues to initiate different reforms to improve the quality and equity of education in the 12<sup>th</sup> Five Year Plan (FYP). In the past two fiscal years, we are delighted that the overall plans and aspirations of the Ministry envisaged in the 12<sup>th</sup> FYP has been progressing well. Among others, in the 2019-2020 fiscal year, the Ministry has obtained approval from the Government for a 50 percent increase in stipend for students, introduced Technical and Vocational Education Training (TVET) in schools as an optional subject, implemented revised ICT curriculum, strengthened Continuous Formative Assessment (CFA), revised provisions for the Central Schools, and initiated Education in Emergency plan as a response to Covid-19 pandemic.

Amidst these achievements, the Ministry continues to face the challenge of providing quality education to all children in an equitable manner. This is further aggravated by the Covid-19 pandemic. Since March 18, 2020, all schools and educational institutions across the country were closed in an attempt to prevent the spread of Covid-19. The pandemic has necessitated the Ministry to go beyond formal classroom settings for both teaching and learning and to provide support to learners. To ensure children in Bhutan continue to learn at home, the Ministry with support from relevant stakeholders¹ have introduced e-Learning programmes as an alternative mode of education to students through Bhutan Broadcasting Service and Google Classroom. The students who could not access to e-Learning platforms were provided with Self Instructional Materials (SIM) and also radio lessons to lower grades (PP-III) to support the SIM. Nonetheless, remote learning will not be able to replace face to face interactive teaching and learning in our schools. Therefore, we share concerns that prolong closures of schools will affect the quality of education in general and particularly for those children in remote and rural places, including children with disabilities.

In view of all changes and initiatives that the Ministry has taken in the past one year, I am confident that the 34<sup>th</sup> EPGI will provide a single point of reference on all education policies, guidelines and circulars that have been issued for our schools, Dzongkhags/Thromdes, ECCD and NFE Centres and other stakeholders.

Finally, on behalf of the Ministry, I would like to sincerely convey our deepest appreciation to colleagues in the field for your continued hard work, commitment and dedication to serve *Tsa-wa-sum*, and wish success in our continuous efforts to take Bhutan's education system to greater heights through provisions of quality and inclusive education to our children.

#### Introduction

The Ministry of Education publishes Education Policy Guidelines and Instructions (EPGI) to provide a single point of reference on all education policies, guidelines and circulars that have been issued since the previous publication. The EPGI is to ensure that there is no gaps between policy and implementation. In this 34<sup>th</sup> edition, the Ministry presents policy guidelines and instructions from July 2019 to June 2020 related to the operation and management of schools, curriculum and assessment, and education programmes.

While EPGI is intended primarily for use by Dzongkhags, Thromdes and schools, it can also be of interest to other educational professionals, development partners and the general public.

### 1. Early Childhood Care and Development

#### 1.1 ECCD Enrolment Age

Starting the 2020 academic year, the admission age range for ECCD was revised to 24 months to 59 months from the earlier 36 months to 72 months. This adjustment has been made with the revision of the admission age in Pre-primary from six to five in line with the government directives issued on 13<sup>th</sup> January 2020. Accordingly, the eligibility for the ECCD enrolment age is also revised in the National Education Policy 2020 (Draft).

### 2. Special Education Needs (SEN)

## 2.1 Data Collection on SEN Module in the Education Management Information System (EMIS)

The Ministry has been collecting data related to Special Educational Programme from Schools annually in using Excel sheets and Google forms in the past. Now, with the integration of SEN module in the EMIS, all ECCD centres and schools enrolling children with special educational needs in the country are required to submit the data online through the system beginning 2020 academic year. The purpose of this data collection is to provide a uniform and systemic educational data for informed decision making and equitable allocation of resources and support services. For details, refer to **Annexure I.** 

#### 3. School Education

#### 3.1 Revision of Pre-Primary Student Admission Age

As per the Government directives, beginning academic session 2020, the admission age for Pre-Primary has been revised and lowered to 'five' from 'six' years both in public and private schools. Therefore, admission into Pre-Primary shall be eligible who completes their 5<sup>th</sup> birthday on or before 5<sup>th</sup> February. However, in the initial stage, if there are space constraints, schools must give priority to older children for admission in the Pre-Primary. For details, refer to **Annexure II**.

## 3.2 Introduction of Technical and Vocational Education and Training (TVET) in schools

Towards creating diverse educational pathways and subject choices for students, the Ministry has introduced TVET as an optional subject through mainstream education in the country. To start with, from the 2020 academic year, TVET as an optional subject is offered from classes IX-XII in seven selected schools (Bayling CS, Rangjung CS, Chumey CS, Khuruthang MSS, Punakha CS, Bajo MSS, and Babesa MSS). Students from across the country who are interested to take up TVET as optional subjects can avail admission in these schools based on the availability of space as detailed in the **Annexure III.** 

#### 3.3 Revised provisions for Central and other Schools

As per the directives of the first joint Cabinet – GNH Commission Meeting held on December 6<sup>th</sup> -7<sup>th</sup>, 2018, the Ministry has carried out a comprehensive review of Central Schools involving all relevant stakeholders that comprise of Principals, Vice-Principals, teachers and education personnel and presented the findings to the Cabinet. The review was also deliberated during the 19<sup>th</sup> National Education Conference. The objective of the review is to assess the effectiveness, equitability, and sustainability of the CS provisions.

Based on the review, the Cabinet has approved the revised provisions for the Central and other Schools under all Dzongkhags and Thromdes on June 21, 2019. Based on the approval, beginning 2020 academic sessions, all students in boarding schools are provided with a mattress, pillow, bed cover, uniform to identified disadvantaged students based on criteria and procedures established, stationaries for all students except students studying in secondary grades in urban schools. For details, refer to **Annexure IV**.

#### 3.4 Revision of Stipend for Schools

From the academic year 2020, the stipend for all feeding schools was revised as per the approval from the Government. The approved revised monthly stipend for each student with three meals is Nu. 1,500, Nu. 1,005 for two meals and Nu. 503 for one meal with effect from 1<sup>st</sup> February 2020. For details, refer to **Annexure V.** 

### 3.5 Establishment of Rigzhung School

As endorsed in the 2<sup>nd</sup> Curriculum and Technical Advisory Board Meeting (CTAB) held on 5<sup>th</sup> July 2018, the Ministry has identified Taktse Central School as a Premier School for language and cultural studies, particularly *Rigzhung*. The school is established to preserve and promote Bhutanese culture, tradition, heritage, history, religion and language that has inherent values of *Tha-Dam-Tshig Ley Gyu-Drey*. Accordingly, Taktse *Rigzhung* Higher Secondary School/Central School has introduced *Rigzhung* from class IX starting 2020 academic year as detailed in the **Annexure VI**.

#### 3.6 Revised drawings and designs for the construction of schools

The Ministry reviewed school designs and drawings to streamline school construction across the Country. The new designs provide clear and concise procedures and methods that can help Architects and Engineers at the Dzongkhags/Thromdes to build school infrastructure with standard quality. The standard designs are based on different geographical zones such as Tropical, Sub Tropical, Temperate and Sub Temperate with estimated costings. For details, refer to **Annexure VII.** 

#### 3.7 Health & Physical Education

#### 3.7.1 Verification of Immunization Status

In line with the resolution of the 66<sup>th</sup> National Assembly held on February 1988, the Ministry of Health reinforced the resolution for the verification of immunization status during admission to both government and private primary schools. In this regard, the Ministry notified all schools to verify the immunization status during the school admission at the primary level with effect from 2020 academic year. For details, refer to **Annexure VIII.** 

## 3.7.2 Advisory Note for the closure of the Schools and Centers due to the COVID-19 (Coronavirus) outbreak

The World Health Organization (WHO) declared the novel coronavirus disease (COVID-19) outbreak a global pandemic on 11<sup>th</sup> March 2020, the first case in the country was detected on 5<sup>th</sup> March 2020, the schools in the country are affected disrupting teaching and learning in a classroom setting. From 6<sup>th</sup> March 2020, all schools, ECCD, NFE/CLC and Youth Centers under Paro, Thimphu Dzongkhags and Thimphu Thromdes were closed for two weeks starting March 6, 2020. On the following day, the same instructions were given to Phuentsholing Thromde, Wangduephodrang and Chhukha Dzongkhags for the closure of all schools, ECCD, NFE/CLC and Youth Centers. Subsequently based on the situation of COVID-19 pandemic regionally and globally, all schools and educational institutes across the country remain closed since March 18, 2020.

As a preventive measure, in line with the advisory note and safety measures, Dzongkhags/Thromdes and schools were notified to adhere to the Ministry of Health's advice and comply with all the COVID-19 safety measures. The notification also requested Dzongkhags and Thromdes to closely support children, students and learners in schools, ECCD, NFE/CLC and Youth Centers, while they are in the centre/school and also while they are travelling back home. For details, refer to **Annexure IX.** 

## 3.8 Operational Guidelines for Cheychey Scouting

In line with the resolution of the 5<sup>th</sup> National Scouts Conference held at Rangjung Central School, Trashigang in 2018, *Cheychey* Scouting was piloted in a few primary schools in all Dzongkhags and Thromdes. Based on the experience, the 6<sup>th</sup> National Scouts Conference

recommended developing an Operational Guidelines for *Cheychey* Guides to coordinate and implement the program uniformly. The detailed Operational Guidelines can be found in **Annexure X.** 

#### 3.9 Admission of all Class X passed Students to Class XI

Beginning in 2019, all class X passed students are enrolled in class XI in public and private schools following the government's directive. This initiative is undertaken in light of several benefits to children for their developmental growth and education.

Similarly, in 2020, the Ministry has provided scholarships to 2138 students to study in private schools with the revised fee amount of Nu 40,000 for day-scholars and Nu. 70,000 for boarding students. However, the boarding provisions are prioritized only to the needy students identified by the respective Dzongkhags/Thromdes and Schools. For details, refer admission instructions for government and private higher secondary schools in the **annexure XI**.

#### 4. Curriculum, Assessment and Examinations

## **4.1** Guidelines for Curriculum Implementation Plan for the Education in Emergency (EiE)

Due to the COVID-19 pandemic, all schools and educational institutions across the country were closed since March 18, 2020. The closure of schools for a prolonged duration is detrimental to students' continual learning and education. As an alternative mode of delivery to educate, engage, and entertain students, the Ministry in collaboration with the Royal Education Council has adapted the EiE curriculum for respective key stages on thematic approaches and delivered remotely through e-Learning platforms. The EiE curriculum is delivered through BBS television, Self-Instructional Material, Radio lessons (for class PP-III), using teacher-student interactive platforms such as social media apps and google classroom.

To make learning effective and engage students during this pandemic, Ministry reminded all schools to comply with the Guidelines for Curriculum Implementation Plan for Education in Emergency. For details, refer to **annexure XII.** 

### 4.2 Implementation of revised ICT Curriculum (Coding)

As a part of the Education Flagship Program, the roll-out of ICT education started with the training of ICT teachers for implementation of a new curriculum (coding) for all range of classes from the academic year 2020. Thus, the Ministry issued the following instructions:

- i. ICT is to be offered as a compulsory subject from classes PP-XII;
- ii. Schools without ICT infrastructure and connectivity will start implementing the ICT subject as they are readied by the Ministry;
- iii. Classes PP-VI are allotted 2 periods/80 minutes per week and classes VII-XII are allotted 3 periods/120 minutes per week.

- iv. Computer Studies, offered as an optional subject, will be discontinued from this year for class XI and in 2021 for class XII; and
- v. Teachers who attended the coding workshop in January-February 2020 at Gelephu are required to teach ICT subjects in their schools.

#### 4.3 Implementation of Continuous Formative Assessment (CFA)

As per the present government's initiative and subsequent discussions in the Ministry in various forums including DEOs and TEOs, the Ministry has decided to do away with the year examination in primary classes (PP-VI) in a phased manner. As an effective alternative to year-end examination, the Ministry in collaboration with the REC has trained all teachers teaching classes PP-III on Continuous Formative Assessment. Accordingly, all schools were notified to implement CFA from classes PP-III starting the academic year 2020. For details, refer to **Annexure XIV**.

#### 4.4 Inconsistent Date of Birth/Name in the Examination Documents

As per the resolution of the meeting between the BCSEA and Department of Civil Registration and Census (DCRC), Ministry of Home and Cultural Affairs (MoHCA), BCSEA notified all the schools and concerned that the Name and Date of Birth (DOB) in class X certificates need to be registered as per the information recorded in the CID or Nationality Certificate issued by DCRC and class XII certificates shall not be considered for change in DOB by DCRC. Further, incorrect DOB recorded in BCRS system if any, will be changed as per the Standard Operating Procedures 2016. For details, refer to **Annexure XV**.

## **4.4** Accountancy Examination (New and Old Curriculum) and Curriculum Rationalization in Commerce

BCSEA notified all the schools offering Commerce stream in the academic year 2020 that the option to appear for new curriculum examination, re-do project work and practical examination by the supplementary and private candidates will not be allowed for Council Examination 2020 due to transition from old to the new curriculum in Accountancy. The Supplementary and Private candidates will have to appear for the old curriculum examination in Accountancy. For details, refer to **Annexure XVI**.

### 4.5 Re-appearing BHSEC Practical Examinations

The BCSEA notified all the schools offering science stream to note that from the academic year 2020, supplementary candidates will be given choices of re-appearing any science subjects unlike in the past where it was mandatory for the candidates to reappear all the three science subjects. The candidates must redo the project work as well if they decide to reappear for BHSEC Practical Examination. For details, refer to **Annexure XVII**.

### 5. District Education Officers' (DEOs') Conference 2019

The DEOs' Conference is one of the most important biennial events of the Ministry. It provides a platform for the education fraternity and relevant stakeholders to come together to discuss issues, plans and policies of the education sector. It also serves as a forum to disseminate information on the major developments and initiatives, share ideas and feedback to strengthen the education system.

The conference was held from 30<sup>th</sup> December 2019 till 1<sup>st</sup> January 2020 at Gelephu LSS, Gelephu Thromde with the theme '*Leveraging ICT for Quality Education*'. The conference adopted 25 resolutions for implementation and follow up. The resolutions of the DEOs Conference 2019 Conference are attached as **Annexure XVIII** for reference and further guidance.

C-3/46/2020/459 dated 19<sup>th</sup> February 2020, the Ministry of Education is directed to stagger the absorption of additional admission of children who complete their 5<sup>th</sup> birthday over few years so that it does not lead to significant distortion of our ongoing educational system as well as immediate additional requirement of teachers and infrastructure.





#### Dashos,

As per the advisory note received from the Ministry of Health vide letter no. PPD/PPMS-25/2019-2020, dated January 30, 2020, the Ministry of Education would like to request Dashos to kindly inform the Chief DEOs/TEOs in respective Dzongkhags/Thromdes on the safety measures to be undertaken by the students, staff and their families on high risk posed by Coronaviruses. According to WHO, coronaviruses are a large family of viruses that cause illness ranging from the common cold to more severe diseases such as Middle East Respiratory Syndrome (MERS-CoV) and Severe Acute Respiratory Syndrome (SARS-CoV). The common signs of infection include respiratory symptoms, fever, cough, shortness of breath and breathing difficulties. In more severe cases, infection can cause pneumonia, severe acute respiratory syndrome, kidney failure and even death.

In this regard, to minimise the risk posed to the staff and students, the Ministry of Education would like to request Dashos to kindly instruct the DEOs/TEOs to disseminate the following:

- Wash your hands frequently with soap and water, which kills the virus if it is on your hands;
- Maintain social distancing at least 1 metre (3 feet) distance between yourself and other people, particularly those who are coughing, sneezing and have a fever;
- Avoid touching eyes, nose and mouth;
- Avoid consumption of raw or undercooked animal products. Handle raw meat, milk or animal organs with care, to avoid cross-contamination with uncooked foods, as per good food safety
- If you have any mild respiratory symptoms, you should take rest until you have recovered; and
- If you have fever, cough and difficulty breathing, seek medical support from the nearest BHUs or hospitals.

With confirmation of the first case of COVID-19 in Bhutan, all Schools, ECCD, NFE/CLC and Youth Centres under Paro, Punakha, Thimphu Dzongkhags and Thimphu Thromde have been closed for two weeks starting from 06.03.2020. On the following day, the same instruction was given to Phuentsholing Thromde, Wangduephodrang Dzongkhag and Chhukha Dzongkhag (Chumithang MSS) for the closure of schools, ECCD, Youth and NFE centres. Therefore, in the wake of the situation, all the schools, ECCD, NFE/CLC and Youth Centres in the rest of the Dzongkhags and Thromdes are requested to stay alert and take preventative measures. This is in reference to press release from Prime Minister Office on the first confirmed case on COVID-19 and continuation to the advisory note sent to all Schools, ECCD, NFE/CLC and Youth centres vide reference number DSE/SPCD/DMU(5.8)/2020/3478 dated 4th February, 2020.

To this effect, Ministry of Education would like to request Dashos to kindly instruct Chief DEOs/TEOs to disseminate the following information to the Schools, ECCD, NFE/CLC and Youth Centres:

- 1. All Schools, ECCD, NFE/CLC, and Youth Centres under those identified Dzongkhags and Thromdes to remain closed as directed by the government.
- 2. In the closed schools, retain all boarding students in the hostel, unless parents come to take them
- 3. Closely monitor and keep track of the health and wellbeing of students in the schools. In addition, Class Teachers and Health Coordinators must provide special attention to students in lower primary classes.
- 4. All staff in the schools, NFE/CLC, ECCD and Youth Centres shall remain in station to provide support whenever necessary.
- 5. Schools must ensure to provide access to counseling services if required.
- 6. In case of schools without counselors, Chief DEOs/TEOs may mobilize counselors from the nearby school, if school requires psychosocial support.
- 7. Dzongkhags/Thromdes must identify a Dzongkhag Focal Counsellor to make reporting and referral systematic for all the Psychosocial support and interventions carried out by school counselors. (Individual Counsellors to make referrals and submit their reports using standard referral and reporting protocols of the School Guidance and Counselling Program to the

- 11. Any School Authority if approached by Prime Minister Office requesting for any kind of support to mitigate the emergency, kindly comply unconditionally.
- 12. All staff to attend phone calls at all times.
- 13. All school buses and utility vehicles to be kept on standby for emergencies.
- Schools/Dzongkhags/Thromdes to share all existing Contingency Plans, Directives and Advisory Notes with Information and communication Unit, MoE.
- 15. Schools/ECCD/NFE/CLC/Youth Centres to follow only notification and messages issued from the Office of Hon'ble Prime Minister, Ministry of Education, Ministry of Health, Ministry of Home and Cultural Affairs, Ministry of Foreign Affairs and not from other sources.
- 16. Upon the closure of the schools and ECCD Centres, students and parents to be briefed on the safety procedures. Schools and ECCD must report the number of students and children upon the closure and opening of the Schools and Centers.
- 17. All school activities are to be carried out as normal, except mass gathering may be avoided.

Furthermore, the information on the following preventive measures could also be disseminated to the schools as shared by World Health Organization:

- 6) To compensate the loss of instructional hours, (a) literacy and numeracy based teaching for primary classes, and (b) theme based teaching for secondary classes, will be broadcasted through Bhutan Broadcasting Service Corporation and other platforms.
- 7) All students to refrain from loitering in public places and large gatherings.
- 8) All staff in the schools, NFE/CLC, ECCD and Youth Centres be available to provide support whenever necessary, and attend to all phone calls on priority.
- Schools must ensure access to counseling services, if required. Additionally, students and staff are advised to avail "Sherig Counseling Services" on Facebook for counseling services.

#### **Cheychey Scouting**

#### **Brief Background**

Cheychey Scouting is the youngest section in Bhutan Scouts Association for classes PP-III children between 5-8 years of age. It is essentially instituted for providing a safe and loving milieu for children to have fun and develop their imagination. Cheychey Scouting is an opportunity for Children to explore and discover new prospects, make new friends, interact with nature and learn to share through co-operation and teamwork.

The introduction of Cheychey Scouting was resolved during the 5<sup>th</sup> National Scouts Conference held at Rangjung Central School, Trashigang in 2018 to infuse good moral values to the young students of classes PP-III. It was then piloted in few Primary Schools in all Dzongkhags and Thromdes. The affirmative feedbacks from the schools and positive responses from the parents made it viable for Bhutan Scouts Association to work towards the institution of Cheychey Scouting in all schools. Moreover, it is in lieu with article 13, Section 14 of National Education Policy (MoE, 2019) which states "All schools shall institute Scouting Programs to support the holistic development of Children and Young People".

The establishment of Cheychey Scout Program for classes PP-III will shore up the wholesome development of the child and groom them from an early age. This unit will further enhance the foundation of Scouting Program.

Though the program maybe accommodative in introducing scouting values<sup>1</sup> at the early stage of schooling, yet, without a Guideline, it would be difficult to implement the program uniformly. Therefore, the 6<sup>th</sup> National Scouts Conference resolved the need to have an Operational Guideline to facilitate the Cheychey Guides to coordinate the program.

The Operational Guideline is expected to help Scout and Non-Scout Teachers of classes PP-III to undertake the program for holistic development of young children.

#### **Operational Guidelines:**

- 1. All students from classes PP-III will be Cheychey Scouts.
- 2. The purpose of Cheychey Scout Program is to inculcate good moral values<sup>2</sup>.
- The Teachers responsible for teaching classes PP-III will be Cheychey Guides and ensure the implementation of Cheychey Scout Programs guided by the Scout Leaders of the respective Schools.
- 4. The registration and collection of fees for Cheychey Scout Units will be coordinated by the School Scout Leaders.
- 5. The Cheychey Scouts will be awarded Scarves as an endorsement of being official members of the Scouting fraternity only after familiarizing them about Scouting and its purpose. It is recommended that Parents award the Scarves for profound significance and consciousness.

<sup>&</sup>lt;sup>1</sup>As Scouts we are guided by these values: Integrity - We act with integrity; we are honest, trustworthy and loyal; Respect - We have self-respect and respect for others; Care - We support others and take care of the world in which we live; Belief - We explore our faiths, beliefs and attitudes; and co-operation - We make a positive difference; we co-operate with others and make friends.

- 6. Unlike the Nachung & Nazhoen Scouts, the Cheychey Scouts will not stay back after School for Troop or Group Meetings for activities. However, Cheychey Scouts maybe engaged once a Week during School Hours for an Hour and Half in purposeful fun & playful activities such as playing Games, Painting, Cooking, Acting, Singing, Dancing or Storytelling.
- Schools could also coordinate activities like Fun Day, Peace Run/ Walk, Historical or Cultural visits and Gatherings involving the Parents and Guardians.
- 8. The Non-Scout Cheychey Guides will be Community Based Scout (CBS) and awarded CBS Scarves during Investiture Ceremony.
- 9. The Cheychey Scouts will abide by the following ideals:
  - a. Cheychey Scout Promise: "I promise to do my duty to God, Self and Others"
  - b. Cheychey Motto: "Sharing"
- 10. Cheychey Scouts to be instituted in all the Schools as a Whole School approach.

#### Note:

 It is recommended that the Guides create creative and innovative activities to engage the Cheychey Scouts meaningfully and to amalgamate lifelong values. However, for reference, the Guides can refer the best practices in other countries to assimilate it in Bhutanese context. But the imagination and creativity of Guides should be the foundation of the activities for Cheychey Scouts to have fun and make them responsible Citizens in the future.



## INSTRUCTION FOR CLASS XI ADMISSION INTO GOVERNMENT HIGHER

#### SECONDARY SCHOOLS (HSS) IN 2020

#### 1.1 Admission Guidelines:

- 1.1.1 All Bhutanese National students awarded with Pass Certificate (PCA) in December 2019 BCSE examination will be eligible for admission in all the Government HSS.
- 1.1.2 A total of 9472 seats will be available for class XI admission in the Government HSS.
- Advisory Note for Student Admissions as circulated vide letter no. DSE/SPCD/Adm-12/2017/84 dated 25th January 2017 should be strictly followed.
- The admission shall be done by a committee under the chairmanship of the Chief Dzongkhag Education Officers (CDEOs)/Chief Thromde Education Officers (CTEOs) and as appropriate in their respective Dzongkhags/Thromdes as per the prevailing admission policy.
- In the event of Dzongkhags/Thromdes not being able to absorb all the pass students, the respective Chief TEO/DEO and as appropriate shall arrange to admit the remaining students in the nearest Dzongkhag/Thromde.
- 1.1.6 All the concerned parents and students are advised to report directly to the respective admission centers with relevant documents. Ministry of Education (MoE) shall not facilitate center
- 1.1.7 All the candidates are required to produce Character Certificate, Transfer Certificate, and Citizen ID card or any other relevant documents issued by the Ministry of Home and Cultural Affairs (MoHCA) at the time of admission in the school.

#### 1.2 Choice of stream and school:

- Students opting Science Stream should have a minimum of 40% in Mathematics, 55% in Science and Grades C in all 3 Sciences. Merit order listing will be based on sum of Science and Mathematics.
- 1.2.2 Students opting Commerce Stream should have a minimum of 40% in Mathematics. Merit order listing will be based on marks in Mathematics.
- Arts: The Merit listing should be based on the aggregate of English and best four subjects.

#### 1.2.4 Rigzhung

- a. Students opting for Taktse Rigzhung should have a minimum of 50% in English and 60% in Dzongkha.
- b. Merit ranking shall be based on the ability ranking mentioned below:
  - Dzongkhag x 5
  - ii. English x 5
  - iii. Best subject 1x3
  - iv. Best subject 2x3
  - Best subject 3x3

## 1.3 Seats:

- 1.3.1 Schools shall maintain the teacher student ratio in the classroom as per the existing policy to facilitate effective teaching and learning that is attuned to the Transformative Pedagogy.
- 1.3.2 Schools shall maintain the boarding capacity as per the existing policy to avoid overcrowding, maintain safety, cleanliness, comfort and overall wellbeing of the students.
- 1.3.3 Students will have to be prepared to study as day-scholars once the boarding seats are filled.
- 1.3.4 The class size should not exceed 36 in both Government and Private HSS

#### 1.4 Venue and date for the placement interview

For smooth placement of students for admission in class XI in Government HSS, the placement exercise will be done at Dzongkhag/Thromde level as mentioned below:

- 1.4.1 The admission should be based on the consolidated result sheets issued to Chief DEO/TEO and Principals by Bhutan Council for School Examination and Assessment (BCSEA).
- 1.4.2 All the students who have passed shall report to the respective Admission Centers on 13th February 2020 at 9:00am for placement and admission in class XI.
- 1.4.3 Those pass students whose parents have been transferred should report directly to the admission center where their parents are transferred on the admission date with a copy of the parent's transfer order.
- 1.4.4 The chairpersons of the respective placement centers are required to submit the details of the students admitted in class XI with their names, school wise and stream wise within 17th February 2019 to the School Planning and Coordination Division (SPCD), Department of School Education (DSE), MoE, Thimphu.
- 1.4.5 Students opting to study Rigzhung in Taktse Rigzhung HSS shall apply online in the Facebook Page of Taktse Central School at <a href="https://www.facebook/taktse2017">www.facebook/taktse2017</a> from 3<sup>rd</sup> to 7<sup>th</sup> February 2020 and the selected students will be confirmed by 11<sup>th</sup> February 2020.
- 1.4.6 All the students admitted in class XI in Government HSS shall report to the respective schools on 25<sup>th</sup> February 2020 for boarders and 26<sup>th</sup> February 2020 for the day-scholars.
- 1.4.7 In order to ensure a seamless admission procedure and to avoid any confusion and inconvenience during the time of admission, all the CDEOs/CTEOs and concerned Principals must properly explain the admission procedures properly.

# INSTRUCTION FOR CLASS XI ADMISSION INTO PRIVATE HIGHER SECONDARY SCHOOLS, 2020

#### 1.1. Admission Criteria

- 1.1.1. All Bhutanese National students who are awarded Pass Certificate (PCA) in December 2019 BCSE-X will be eligible for admission into class XI in government or private schools without merit ranking.
- 1.1.2. The Ministry of Education (MoE) will provide scholarship to 2700 students in private schools.
- 1.1.3. Students opting to apply to any of the private schools within the country, should first register online from 8<sup>th</sup> January till 15<sup>th</sup> January 2020 only in MoE's website www.education.gov.bt
- 1.1.4. After the completion of admission to private schools, the MoE in coordination with the office of DEOs, and TEOs will place the remaining class X pass students in the Government schools based on the intake capacity of the schools.
- 1.1.5. The Royal Government will award a revised full scholarship amount of Nu. 40,000/- (Forty Thousand) only to day scholar students admitted in the private schools.
- 1.1.6. Similarly, a full and revised amount of Nu. 70.000/- (Seventy Thousand) only, will be awarded to the students availing boarding services. However, this scholarship is limited to the needy students only identified by the respective schools around the country, following rigorous and formal procedure of identification and selection.
- 1.1.7. The choice of streams will be left to the interest of the student and criteria set by the respective schools.
- 1.1.8. Once admitted in a school, the students shall not be allowed to change the schools unless they do so at their own expenses.
- 1.1.9. If a student on government scholarship fails in class XI or XII, he or she will not be eligible for government scholarship to repeat.
- 1.1.10. All the students are required to produce Character Certificate, Transfer Certificate, and Citizen ID card or any other relevant documents issued by the Ministry of Home and Cultural Affairs (MoHCA) at the time of admission in the school.
- 1.1.11. All Government scholarship students including others must be taken care by the school management to ensure their safety, security and discipline.

## 2.1. Special Conditions

2.1.1. In case of children opting for admission in private higher secondary schools is lesser than the scholarship allotted, the MoE shall coordinate placing the remaining students in various private schools after the completion of admission in Government schools based on a set criteria.

- 4.1.3. All admitted students shall report to the respective schools on 9<sup>th</sup> February 2020 for boarders and 10<sup>th</sup> February 2020 for day scholars.
- 4.1.4. The Principals of the schools are required to submit the details of the students admitted in class XI with their names and stream of choice latest by 14<sup>th</sup> February 2020 to the Private School Division (PSD), Department of School Education (DSE), MoE, Thimphu.
- 4.1.5. Instruction for class XI admission into Government Higher Secondary Schools will be announced on 31st January 2020 in MoE's website.
- 4.1.6. In order to ensure a seamless admission, all the principals and proprietors must explain the admission procedure properly.

Under the ICT Flagship Programme, the Ministry of Education in collaboration with Royal Education Council (REC) and Department of Information Technology and Telecom (DITT) has worked on enhancing coding education from classes PP-XII. Accordingly, 277 teachers from schools ready with infrastructure and Internet connectivity were trained on Scratch and Python programming.

The Ministry of Education would like to inform all schools on the following for immediate compliance:

- 1. ICT is to be offered as a compulsory subject from classes PP-XII.
- Schools currently without infrastructure and connectivity will start implementing the ICT subject as they are readied by the Ministry of Education.
- Classes PP-VI are allotted 2 periods/80 mins per week and classes VII-XII are allotted 3 periods/120 mins per week. Overview of period distribution revised by REC is attached.
- Computer Studies, offered as an optional subject, will be discontinued from this year for class XI and in 2021 for class XII.
- Teachers who attended the coding workshop in Jan-Feb 2020 at Gelegphu are required to teach ICT subjects in their schools.

# Implementation of Continuous Formative Assessment (CFA) in Primary Education in the Academic Year 2020

As per the directives of the Government and the resolution of the 19th National Education Conference, the examinations in primary classes (PP-V) have been decided to be phased out. The NCE also resolved that the Royal Education Council (REC) should develop an alternative assessment system. As a result, REC in consultation with the Ministry of Education decided to develop and implement the Continuous Formative Assessment (CFA), at the initial phase, at the Key Stage 1 (Classes PP-III) with effect from 2020 academic session, and at Key Stage 2 (Classes IV-V) in the later academic years. The CFA would replace the examination system to facilitate students learn and develop competencies in the learning subject areas through rigorous continuous and formative assessment, and feedback system.

The effective Implementation of CFA cails for an unfailing support and collaboration from Dzongkhags and schools and other relevant stakeholders. Towards ensuring that the CFA achieves the desired outcomes, it is crucial to establish enabling conditions for seamless implementation of the change. As such, the schools and Dzongkhag/ Thromde education sectors are required to make the following arrangements and preparations.

## Curriculum and assessment adjustments

- Do away with the existing written examinations, unit tests, monthly test and class test practices
  with immediate effect at Key Stage 1 (PP-III). However, tests as in the form of continuous
  assessment techniques within the CFA is recommended in the respective subjects as may be
  required by the curriculum.
- By doing away with the written examinations viz, mid-term and annual, schools gain additional 20 instructional days. Hence, it is recommended that the schools use these additional days for classroom teaching-learning purposes.
  - Besides the assessment tools and techniques that are integrated in the respective subjects, teachers are encouraged to design and use diverse assessment techniques and tools as per the curriculum learning standards and objectives.
  - 4. In order to keep track of student learning, a personal file or portfolio for each student for each subject is required to be maintained. The file should contain all the records of student learning which includes, work samples, assessment records for all subjects, interventions provided, remedial, and personal traits records.
  - Every subject teacher is required to keep records of all the students and enter the information/ data in the personal file accordingly throughout the academic session. Use of ICT is highly encouraged to make the work easier and information reliable.
  - The personal files should be made available to parents, relevant stakeholders upon request. The records contained in the file should be used to report on the status of the student learning and progress in their personal traits.

- 7. When a student is transferred to another school, upon completion or voluntary change of school during an academic session, the school should send the personal file officially to the school where the student is being transferred to, or hand over the document to parents, officially sealed, during the issuance of transfer transcripts.
- A descriptive summary of student learning and competencies in cognitive, affective and psychomotor domains should be reflected in the progress report card.
- 9. Student performance is no more equated with marks. Based on the quantity and quality of their performance, students are graded as Beginning, Approaching, Meeting, or Exceeding. Children are expected to move to the next higher grade progressively in this system of assessment. If children fail to progress, teachers are required to provide remedial classes until they achieve the required competencies.
- New version of the Progress Report shall be used to report the performance or achievement of students.
- 11. Schools should enhance the development of personal, social, cultural, national values, etc. through the use of diverse rigorous assessment techniques and tools. Therefore, the domain of values should be accorded greater emphasis than the other domains as is the present trend.

## Arrangement of enabling conditions for effective implementation of CFA

- The integration of CFA in all the primary curricula requires assessing and keeping track of student learning continuously throughout the academic session. Every subject teacher needs to assess and keep track of individual student's learning and achievement. Therefore, considering the importance of building strong educational foundation and for effective implementation of CFA to enable every student to meet the curriculum learning standards, objectives and competencies, it is recommended that one teacher teaches one subject.
- In order to ensure the effective implementation of CFA integrated curriculum, schools and teachers require continuous support and monitoring. It is recommended that relevant stakeholders provide the required support to teachers and schools.
- 3. Schools are required to institute an assessment committee to:
  - a. review the CFA practices quarterly,
  - b. perform assessment auditing annually,
  - c. facilitate teachers in the implementation of CFA,
  - d. review consolidated results and records of students learning, and
  - e. make recommendations for continuous improvement of the CFA practices.
- Provisions must be made to avail professional development avenues and opportunities for teachers on assessment.

1

Within the available space, effort must be made to minimize the class size (number of students in each class) to facilitate the effective implementation of CFA.

Dzongkhag and Thromdhe Education sectors are required to instruct schools under their jurisdictions to implement the CFA in P-III from 2020 academic session, and provide necessary support and create enabling conditions to facilitate schools for its effectiveness.
