Important Notes:

1. The recommendation from the Dzongkhag for transfer shall be mandatory.
2. The internal transfer within the Dzongkhag shall be given priority in order to minimize the financial burden for candidates.
3. In the event the applications exceeding the actual vacant posts or more than one applicant opting for transfer at the same school, following criteria shall be adopted for the selection process:
 - Seniority in service;
 - Rural posting;
 - Moderated IWP score (Last two years);
 - SPMS score of the school for the previous year;
 - LFS;

- Feedback from Teachers/staff of the school.

4. As per the Notification of the Ministry of Finance vide no. MoF/Budget Notification/2020-21/02 dated 29th June 2020, there shall be no transfer benefits.

5. The transfer of the spouse (if Teacher/Support Staff) shall depend on the requirement (Subject/position) respectively in the Dzongkhag where you are being transferred.
