### NOTIFICATION

In pursuant to the notification from the Royal Civil Service Commission vide letter no. RCSC/LD-63/NOTIFICATION/4772 dated September 20, 2021, the Ministry of Education would like to request all the aspiring candidates eligible for promotion as Specialist (ES3A to ES1A), Principal I, and Vice Principal at P1A to take note of the following:

1. Submit the title for publication/research to the Ministry for endorsement.
2. Recommendation from the respective Dzongkhag/Thromde HRC is mandatory.
3. The publication/research title should be aligned to your Area of Specialization.
4. Accordingly, the Peer Review Committee (PRC) formed for the January 2023 promotion cycle will review the professional standards of ONLY the publication/research whose titles were recommended by the respective Dzongkhag/Thromde Human Resource Committee (HRC) and endorsed by the Ministry's HRC.
5. The deadline for submission of the publication/research title to the Ministry is **August 10, 2022**.

The Ministry would also like to remind you that the approval of the topics for the research/publication does not correspond to the affirmation of its quality and professional standard. The vetting of the research/publication itself would be conducted by the PRC formed by the Ministry. Therefore, please be informed that the approval of the promotion shall be subject to meeting all the criteria, including the recommendation and approval for the title from the Dzongkhag/Thromde HRC and Ministry's HRC respectively, and recommendation from the PRC after the research and publication has been vetted.

This is being issued as per the decision of the 352<sup>nd</sup> HRC meeting held on July 26, 2022.
