- 3. The Peer Review Committee (PRC) will be formed at the Ministry level who will review the professional standards of **ONLY** the publication/research whose proposals were recommended by the respective Dzongkhag/Thromde HRC and endorsed by the Ministry.
- 4. The deadline for submission of the research/publication proposal to the Ministry is **December 31, 2022** and will not be accepted after the deadline.

We would like to inform you that the approval of the topic(s) for the research/publication will not affirm its quality and professional standard. The vetting of the research /publication will be conducted by the PRC formed by the Ministry during the promotion cycle. Therefore, please be informed that the approval of the promotion shall be subject to meeting all the criteria, including the recommendation and approval for the title from the Dzongkhag/Thromde HRC and the Ministry's HRC respectively, and recommendation from the PRC after the research and publication has been vetted.

This is being issued as per the decision of 362nd HRC meeting held on November 29, 2022.
