# Notification on Transfer Appeal

The Ministry of Education would like to notify all that the window for the Transfer Appeal for the academic year 2022 has been opened in the EMIS from 16<sup>th</sup> December 2022.

Please refer to the table below for the schedule:

2	Review & approval of transfer by the school HRC	31-12-2022	13-01-2023
3	Review & approval of transfer by the Dzongkhag / Thromde HRC	14-01-2023	27-01-2023

The applicants are hereby informed to take note of the following information:

- 1. Who CAN submit an appeal for transfer through the system?
  - a. Candidates whose transfer has not been recommended by the School, Dzongkhag/Thromde and Ministry can submit appeal through **"Transfer Appeal"** module;
  - b. Candidates who did not apply during the inter transfer window can also submit an application in the system through "Inter Transfer" module. Please note that this has been considered since the system is new and it is applicable for the year 2022 only.
- 2. Who CANNOT submit an appeal for transfer through the system?
  - a. Candidates whose transfer has been approved by the Ministry based on the requirement in any of the opted places.
  - b. Candidates who have withdrawn their transfer application.
- 3. Once you mention all three Dzongkhag/Thromde preferences in the option list, you **AGREE** to go to any of the opted places. Transfer cancellation shall **NOT** be entertained.
- 4. Hard copies shall **NOT** be accepted. All the applicants **MUST** appeal through EMISv3 within the transfer appeal window.
- 5. Late application shall **NOT** be entertained.

This is being issued as per the decision of the 363<sup>rd</sup> HRC meeting held on 7<sup>th</sup> December 2022.

For more information on the parameters, kindly refer the Notification on Annual Transfer vide MoE/DoS/HRD/Transfer/2022/284 dated 27<sup>th</sup> July 2022 issued by the Ministry.
