In accordance with the approval from the Royal Civil Service Commission dated July 5, 2023, the Ministry of Education and Skills Development is pleased to announce the vacancy for the following post for an initial period of 2 years (*extendable*) based on performance and requirement in the specialized field/subject.

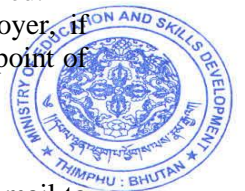
#### 1. Eligibility Criteria for Regular Contract (Teacher III, P5 B):

- 1.1 Eligible only for self –financed PGDE candidates graduated in 2023 from the two Colleges, Paro College of Education and Samtse College of Education.
- 1.2 Dzongkha-17, English-3, History-3, Geography-1, Economics-4 and Mathematics-1.
- 1.3 The initial contract duration is of 2 years from the date of appointment with a possibility of extension based on performance and requirement in the specialized field/subject. They shall be governed by chapter 5, clause 5.10.1 of BCSR, 2023.
- 1.4 Candidates must apply through Zhiyog Recruitment System (ZRS) on or before **27<sup>th</sup> July, 2023**.

#### 2. General Term and Conditions:

- 2.1 The placement to the respective Dzongkhag/Thromdes will be based on merit ranking as per the academic result of 2023. The HRD will announce rest of the details in Ministry's website.
- 2.2 The candidates must undergo and pass the drug test for their appointment as Teacher by the Ministry of Education and Skills Development. Failing to pass the drug test shall be disqualified for the appointment. The final date for the drug test will be made available/communicated after the confirmation of the selection.
- 2.3 The Ministry will verify with the Royal Bhutan Police (RBP) for any adverse record. Should there be any adverse record against the candidate; the candidates shall be informed and disqualified.
- 2.4 The candidates must also furnish No Objection Letter (NOC) from the current employer, if employed. If the candidates fail to submit NoC and are found out to be employed at any point of time, their appointment as Contract Teacher shall be revoked with immediate effect.
