The selected candidate must produce a negative drug test result and failing to do so will lead to disqualification.
2. The selected candidates will be required to sign an Undertaking Form with the ministry
3. Candidate must submit a complete set of the following documents to the HRD:
  - a) Employment Application Form 4/1 (1 copy)
  - b) Contract Agreement Form 4/2: 2 Copies duly filled and signed in every page
  - c) Oath of Allegiance 4/6 (2 copies)
  - d) Copy of valid CID
  - e) Copies of academic transcript and certificate(s)
  - f) Copies of relevant training certificate
  - g) Valid Medical Fitness Certificate
  - h) Passport size photo (3 nos.)
  - i) No Objection Letter, if employed
  - j) Security Clearance Certificate
  - k) Copies of certificate (s) on extra-curricular activities
  - l) Legal Stamps (6 nos.)
4. The candidate is informed to purchase a drug test kit from Bhutan Trading and produce medical documents if you are on medication for the purpose of drug testing and bring it on May 14, 2024.
